

We have GREAT NEWS! Your nonprofit has been nominated!

One of our members has nominated your organization to be considered for our quarterly donation.

At 100 Women Who Care RI, our mission is to leverage the power of collective giving by bringing women together to make a greater impact in our community.

What we do: Each quarter, our members gather to learn about nonprofits supporting the Rhode Island community. 100% of our member donations go directly to the nonprofit. Additionally, our Rhode Island chapter is now included in a 50% match for of each of our quarterly donations. In total, the elected nonprofit currently receives an average of \$7,500. To date we have given away more than \$300,000 to help support local nonprofits!

How it works: Each quarter we choose three nonprofits through a random draw from our existing nominations to be considered for voting. As a group we engage in a democratic vote for a single nonprofit to receive the total of our individual donations. Your organization might not be chosen at a particular meeting or if randomly drawn as one of three, may not carry the vote. The good news is that your organization still remains an active nomination! So while you may not receive funding the first time, you have many chances in the future.

PART 2: THE NONPROFIT AGREEMENT (to be completed by nonprofit)

1. Please review and confirm that your organization meets the following criteria in order to be considered for funding:

100 Women Who Care RI's intention is that 100% of contributions stay in the state of Rhode Island to benefit local communities. The mission and constituency of the nominated nonprofit must meet this criteria. International or national nonprofits that do not work for the benefit of the RI community will not be considered.

Contributions will not be made to:

- Organizations without 501(c)(3) tax-exempt public nonprofit status as defined by the Internal Revenue Service.
- Individuals.
- Organizations that: 1) Promote a particular political, religious, or ideological point of view; 2) advocate for a particular program of social or political action; 3) support specific public policies or legislation; 4) lobby.
- Religious institutions when the contribution would support sectarian activities.
- Organizations that discriminate on the basis of race, color, religion, gender, gender expression, age, national origin, disability, marital status, or sexual orientation in any of its activities or operations.

2. If your organization is funded, you agree to the following:
Organization will NOT publish or use the individual names and contact information of 100 Women Who Care Rhode Island members as donors for future solicitations or publicity;
Organization agrees that the funds will be earmarked as agreed upon in application;
Organization agrees that the funds must be used to benefit the Rhode Island community;
Organization will send a representative to the next meeting of 100 Women Who Care Rhode Island to inform the membersh how the funds donated by our members created an impact in the organization;
Organization will make at <i>least</i> two social announcements: one after notification of grant award; and one after actual donation with total. If you have a newsletter (print or email) please include a message a of thanks.
